AGREEMENT ASSUMING RISK OF INJURY OR DAMAGE, WAIVER AND RELEASE OF CLAIMS,
AND INDEMNITY AGREEMENT

The undersigned, being over the age of eighteen, have made a voluntary request to enter upon the premises of Northwest Seal Rock and Lighthouse, Saint George Reef, off the Pacific Coast of Del Norte County, California, hereinafter referred to as "Property;" and WHEREAS, the St. George Reef Lighthouse Preservation Society, tenant of the Property, is willing to allow me to enter upon the Property: NOW, THEREFORE, in consideration of the permission granted, I do hereby agree: 1. That I am aware that access to, entry upon, and exit from the Property is inherently dangerous and that I may be subjected to the risk of death, personal injury, or damage to my property during an attempt to enter upon the Property, during an attempt to exit from the Property, or while upon the Property, and that I freely, voluntarily, and with such knowledge, assume the risk of death, personal injury, or property damage arising from or in any way connected with the Property. 2. That the County of Del Norte and the St. George Reef Lighthouse Preservation Society, their elected and appointed councils, boards, commissions, officers, agents, employees and volunteers, and each of them, shall not be responsible or liable for any injury, damage, loss, or expense, either to me or my property, incurred while attempting to enter or exit the Property or while upon the Property and resulting from any negligent act or omission on the part of any elected or appointed officer, commissioner, agent, employee, or volunteer of the County of Del Norte or St. George Reef Lighthouse Preservation Society. 3. For myself, my heirs, executors, administrators, and assigns, to defend myself and indemnify the County of Del Norte and/or the St. George Reef Lighthouse Preservation Society, their elected and appointed councils, boards, commissions, officers, agents, employees, and volunteers against any and all manner of actions, causes of actions, suits, debts, claims, demands, or damages, or liability or expenses of every kind and nature incurred or rising by reason of any actual or claimed negligent or wrongful act or omission of mine while attempting to enter or leave said Property or while upon said Property.

Saint George Reef Lighthouse Tour rules/ Deposit and refund policy:

1. All lighthouse tour tickets require a 50% deposit to secure a ticket. (50% is \$175.00) The balance will be due at the airport before boarding the helicopter.
 2. All debit and credit cards, PayPal, checks, and cash are accepted
 3. **THE DEPOSIT IS ONLY REFUNDABLE IF THE TOUR IS CANCELED BY SAINT GEORGE REEF LIGHTHOUSE PRESERVATION SOCIETY NO OTHER REFUND REQUEST WILL BE HONORED.**
- The cost of securing a helicopter to travel here costs several thousands of dollars. We base our costs on a high daily charge minimum by the helicopter charters. We are required to pay them whether someone shows up or not.
4. Please be at the Crescent City airport by 8:00 A.M., or a time designated by us for the flights out to the lighthouse. Dress in layers for the possibility of cold weather.
 5. We want this trip to be an unforgettable experience, Saint George Reef is a beautiful and DANGEROUS PLACE. We want you to see as much as possible, but under no circumstances go anywhere unescorted by a docent, lean on railings, or go near the edge of the caisson or balcony.
 6. All helicopter groups need to stay together so as not to disrupt our helicopter trips.
 7. **BE ADVISED TO USE THE RESTROOM FACILITIES SHORESIDE BEFORE BOARDING THE HELICOPTER) SOMETIMES THERE ARE DELAYS GOING BACK AND FORTH TO THE LIGHTHOUSE. PLEASE MAKE THIS ALLOWANCE IN YOUR PLANS.**
